Dear Benji, It was a pleasure hearing from you after such a long period of silence.

We are all fine here. My married daughter now has two sons and my son, recently got married now has a daughter - so Harriet, who is still working - are now getting old.

I left Lesotho High School in June, 1985 - in fact I was dismissed by the Expatriate and The Board of Governors ~~at~~ who was then principal.

I sued the Board for wrongful and unlawful dismissal. Two months ago I was able to collect over fifteen thousand rands after ~~winning~~ my appeal ~~was~~ against the dismissal was upheld. However since 1985 to date I have been employed as Executive Officer of the Lesotho Chamber of Commerce and Industry - I have no intention of going back to teaching - at least for the moment.

When Prof ~~expresso~~ resigned his post at Wits at the end of 1957, we knew the date was near. It was certainly a well-guarded secret. His change in temperament, touched with impatience told us as time went on. But it was only a

day or two before the Friday 18th March, 1954 meeting of
the Executive that we guessed it would be Monday next.
We were not surprised when this was announced
on Friday.
