It is hereby notified that the Superintendent of Natives will visit the under mentioned centres on the dates named for the purpose of collecting Taxes from Natives. It is requested that farmers and other employers of natives will kindly make the contents of this known to their native employees, and warn them that their Taxes must be paid at one or other of the centres named. Failure to pay renders the Taxpayer liable to the penalties under the Act. When payment is made the previous years receipts must be surrendered and all natives paying for the first time must appear in person. The accompanying Form must be completed by all farmers and returned to this office or delivered to the Superintendent of Natives when on tour.
